

3M Board Declares Quarterly Dividend

The Board of Directors of 3M (NYSE:MMM) today declared a dividend on the company's common stock of 63.5 cents per share for the fourth quarter of 2013, payable Dec. 12, 2013, to shareholders of record at the close of business on Nov. 22, 2013. 3M has paid dividends to its shareholders without interruption for more than 97 years.

As of Sept. 30, 2013, 3M had 673,269,679 common shares outstanding and 92,590 shareholders of record.
